# **Concert Participation Terms and Conditions**



Participation in the End of Year Concert is subject to the following special Terms and Conditions, which apply in addition to our general enrolment terms.

Please read carefully. Submitting a participation form indicates your full acceptance of these conditions.

## Payment of Fees

- Concert participation forms must be returned by **5pm Friday 26<sup>th</sup> September 2025.**
- Participation fees must be fully paid by 5pm Friday 26th September 2025.
- An indication of participation without a completed payment will not be allocated a costume and will be removed from all performance pieces.
- Any overdue class fees or outstanding invoices must be paid before costumes will be released to the student for participation in the concert.

#### Attendance and Rehearsals

- Attendance is **compulsory** at the following to be eligible to perform:
  - o Dress Rehearsal
  - o Theatre Induction
  - o On-Stage Rehearsal
- Non-attendance at the Theatre Induction and On-stage Rehearsal will result in nonparticipation without exception. Theatre Induction is mandatory for all participants for safety reasons.
- Participants must always follow the directions of the Theatre Manager. Non-compliance will result in non-participation for safety reasons.
- Students must maintain regular class attendance to prepare their performance pieces.
  - Students with **frequent absences** may be removed from part or all of a concert piece at the teacher's discretion.
  - Significant or ongoing absences may result in full removal from the concert at the Director's discretion.

#### **Refund Policy**

- No refunds for change of mind will be made after **Saturday 27**<sup>th</sup> **September 2025** or once costumes have been ordered.
- A refund, or partial refund may be made at the discretion of Simply Ballet in certain circumstances. A refund must be applied for in writing with evidence as required.
